Most recently, she played a central role in a five month trial of a groundwater contamination case brought under CERCLA, in which Riker's client prevailed at trial. Through Ms. Kabbash's wide-ranging experience, she has developed expertise in federal and State court practice, at both the trial and appellate levels. In a published decision, the Utah Court of Appeals decided a matter of first impression in the state (which only a handful of other courts have considered) and agreed with the minority position that Mr. Borrelli was advocating on behalf of the firm's client. Previously, Mr. Borrelli obtained a "no cause" verdict after a six-day jury trial in which the plaintiff claimed personal injuries, property damage and economic loss due to mold exposure. He graduated Boston College in 1997 and received his law degree from Fordham University School of Law in 2000.
